## FEES AND CHARGES

[For hostel accommodation of class XI (2022-23) students]

1. **First instalment fees (to be paid at the time of admission):**

2. **Second Instalment :** Guardians are requested to pay the monthly charges for the months of September to December, 2022 on or before the 1<sup>st</sup> week of September, 2022 @ Rs. 4,600.00 per month.

3. **Third Instalment :** Guardians are requested to pay monthly charges for the months of January to March 2023 on or before 1<sup>st</sup> week of January, 2023 @ Rs. 4,600.00 per month.


❖ **Mode of Payment:**

At the time of admission, the first instalment is to be paid by the guardians for securing admission of their wards. Payment is to be made by cash or bank transfer or demand drafts. Demand Drafts should be drawn in favour of 'RAMAKRISHNA MISSION VIDYAPITH, PURULIA'. Drafts must be drawn from S.B.I or P.N.B. In case of bank transfer, the amount should be transferred to RAMAKRISHNA MISSION VIDYAPITH, PURULIA, A/C Number: 0742010102003, IFSC Code: PUNB0074220, PUNJAB NATIONAL BANK, VIVEKANANDANAGAR BRANCH. Once the admission is completed no amount will be refunded, if the ward is withdrawn from the school.

❖ **Note:**

1. If student's expenditure exceeds his personal deposits, guardians will have to reimburse the extra amount incurred.
2. Caution money deposits are refundable after six months from the date of departure of the ward after deductions, if any, on accounts of wear, tear, etc. No fund is payable after the lapse of one year from the date of final departure.
3. The statements of the accounts will be given to guardians twice in a year.
4. If any student applies for any kind of special coaching, guardians will have required fees for the purpose.
